# JUNIOR FAIR BOARD MEMBERS

## WHAT IS IT?

---

The Junior Fair Board is a youth-oriented program designed for students in Colusa County. Members are selected from any of the five public high schools: Arbuckle, Colusa, Maxwell, Princeton, and Williams.

## HOW IT WORKS:

---

Any student who will be a Junior during the 2025-2026 school year and is regularly attending one of the five public high schools in Colusa County is eligible to serve on the Junior Fair Board.

Members serve a two-year term. Applicants do not have to be involved in 4-H or FFA to serve as a member of the Junior Fair Board.

## WHAT IS EXPECTED?

---

Junior Fair Board Members are expected to attend one Junior Fair Board meeting each month throughout the year and serve on at least three standing committees prior to the Colusa County Fair.

# HOW TO ENTER ONLINE

All livestock entries must be submitted online through the fair website.

To access the online entry system:

- Go to [www.colusafairgrounds.com](http://www.colusafairgrounds.com)
- Click on County Fair
- Select Livestock Info
- Scroll down to Exhibitor Information

Under Exhibitor Information, you will find:

- Entry Instructions (downloadable document)
- The link to enter online
- County Bred Affidavits (if applicable)

## ***Before You Start***

Before beginning your online entry, make sure you have the following ready:

- Two (2) required animal photos (see photo requirements below)
- Your YQCA Certificate Number
- A PDF copy of your YQCA certificate ready to upload
- Your animal's official identification number (ear tag, scrapie tag, or ear notch)

## ***Required Photos***

Two (2) photos are required for each animal entered:

- Full Body Photo with Exhibitor  
A clear photo of the entire animal with the exhibitor standing beside it.
- Headshot with Identifying Markers Visible  
A close-up photo of the animal's head showing all identifying markers (ear tag, tattoo, ear notch, etc.) clearly visible.

Photos must be clear and easy to read. Blurry or incomplete photos may result in delays or rejected entries.

## ***Tag Identification Requirements***

During the online entry process in Showworks, you will be asked to enter a tag number. Please enter the appropriate official identification for your species:

- Sheep and Goats: USDA Scrapie Tag number
- Cattle: Farm tag number
- Swine: Ear notch identification

The identification entered online must match the identification shown in your required headshot photo.

# ENTRY DEADLINE SCHEDULE

Entries are **NOT** considered complete unless online entry, payment, and all supporting documents and photos are received by the entry deadline. Entries will be disqualified if deficiencies are not cleared before the **10-day grace period** has concluded.

Submission procedures and requirements will be published at a later date. Exhibitors are responsible for reviewing and complying with the finalized instructions once released.

## **EAR TAG PACKETS**

- Full Body Photo with Exhibitor  
A clear photo of the entire animal with the exhibitor standing beside it.
- Headshot with Identifying Markers Visible  
A close-up photo of the animal's head showing all identifying markers (ear tag, tattoo, ear notch, etc.) clearly visible.

Photos must be clear and easy to read. Blurry or incomplete photos may result in delays or rejected entries.

# LIVESTOCK DEPARTMENT RULES

The Junior Department is for young people who would like to enter their exhibits at the Colusa County Fair. The Fair will make every effort to accommodate these exhibitors by providing appropriate departments, divisions and classes for organized groups such as FFA and 4-H as well as opportunities for Independent Exhibitors who are not members of an established club or organization.

Independent exhibitors may compete in the appropriate age class alongside FFA or 4-H exhibitors. If a significant number of independent exhibitors exist, separate divisions and classes may be created exclusively for independent exhibitors. We wish all exhibitors the best of luck and look forward to welcoming you to the Colusa County Fair.

## ELIGIBILITY AND AGE REQUIREMENTS

---

### **4-H Age Requirements:**

The levels of membership for 4-H are age based. Each level is defined as follows:

#### ***Primary Members:***

Must be 5 years old by December 31 of each calendar year. Primary members cannot enroll in large animal projects.

#### ***Junior:***

Exhibitor 9-10 years of age as of December 31 of each calendar year.

#### ***Intermediate:***

Exhibitor 11-13 years of age as of December 31 each calendar year.

#### ***Senior:***

Exhibitors who are 14-18 years of age as of December 31 of each calendar year.

### **Grange Members**

Must be at least 5 years old on December 31 of each calendar year to exhibit. They may exhibit until the end of the calendar year in which they reach age 19. All Grange Youth must be 9 years old on December 31 of each calendar year to exhibit large animals.

### **Independent Exhibitors**

Must be at least 9 years old by January 1 of each calendar year. Exhibitors are eligible to compete/exhibit through December 31 of the year in which they turn 19 years of age.

### **FFA Members**

May participate as members until the end of the calendar year following the year of graduation from high school. For example, a graduate this year is eligible until December 31, of next year.

### **One Year Out of High School Policy**

An exhibitor may participate in the Colusa County Fair one year after graduating from high school as a 4-H or FFA member provided they have met all the rules and requirements of the organization. Independent exhibitors may only complete one year after graduating from high school, provided they were entered as an independent in the previous year.

## **COLUSA COUNTY FAIR SHOW UNIFORM**

---

### **FFA**

Show uniform to be worn by all FFA exhibitors while showing at the fair shall consist of white pants, a white shirt, and the official FFA jacket with the official FFA four-in-hand necktie or scarf. Shirts must be tucked in and have short or long sleeves (not sleeveless). Hats or headgear of any kind shall not be worn while showing.

### **4-H**

Show uniform to be worn by all 4-H exhibitors showing at the fair shall consist of white pants and a white shirt. Shirts must be tucked in and have short or long sleeves (not sleeveless). 4-H members must wear the official 4-H tie or scarf and hat. The 4-H hat must be worn on the exhibitor's head.

### **Independent Exhibitors**

Independent Exhibitors showing livestock must wear white pants and a white shirt. Shirts must be tucked in and have short or long sleeves (not sleeveless).

### **Grange Members**

Grange Members showing livestock must wear clean blue jeans, red Grange vest, and a white shirt. Shirts must be tucked in and have short or long sleeves (not sleeveless).

### **Groups**

Exhibitors assisting with group or pen classes must also wear their appropriate show uniform.

# INDEPENDENT LIVESTOCK MARKET EXHIBITOR

---

To show and sell at the Colusa County Fair an independent exhibitor must register with the Colusa Fair Entry Office by **November 30th of each year**. If this date falls on a weekend, it is by the Friday before.

At this time, you must list:

1. Project or Species
2. Name of the Adult that will be supervising you while on the Fairgrounds.
3. Parent/Guardian must sign the registration at this time.

## **Exhibitor Age and Other Requirements:**

1. Limited to Colusa County Residents only.
2. Must be 9 years old or in the 4th grade by January 1 of each calendar year.
3. Exhibitors are eligible to compete through December 31 of the year in which they turn 19.
4. Must not be affiliated with any Junior Organization (4-H or FFA) within 60 days (120 days for market beef) before the fair in the same livestock project (species).
5. Must provide certificate of Liability Insurance coverage for themselves as required by local and State Rules. (May purchase through Fair Office)
6. Must attend scheduled pre-weigh-in day or receive written permission to be excused. If not attending the weigh-in day, exhibitors must submit a picture of themselves and their animal subject to the same rules as outlined for all livestock exhibitors. Additionally, all independent market animals must be tagged by a fair representative.
7. Must make a project presentation to the Fair Board of Directors, or designees during the months of March, April, or May. All presentations will be graded/scored by the Fair Board of Directors. Presentations must be a minimum of 5 minutes in duration. Exhibitor must receive a score of 70% or higher in order to be eligible. Presentations will be scheduled by the Colusa County Fair Management.
8. Keep a record book (provided by the fair) that must be turned into the livestock office by 4:00 p.m. Tuesday of fair week. To be reviewed by a Fair Board member and a JLA Committee Representative.
9. A thank you note MUST be written to the buyer and turned into the Livestock Office or Front Fair Office in an addressed, stamped envelope. Checks will NOT be issued until thank you notes are received.
10. Independent exhibitors shall show in age-appropriate division as per their age/year in school as of January 1 of each calendar year. 8th Grade/13 or under = 4-H; High School/14 or over = FFA
11. Independent exhibitors may only compete one year after graduating from high school provided, they were entered as an independent in the previous year.
12. Please note that members transferring from 4-H, FFA or Grange to Independent may be ineligible to participate at fairs as an independent exhibitor if documented disciplinary action involving their project(s) has been taken against them by 4-H, FFA or Grange organizations. Length of ineligibility shall be determined by Fair Management.

13. Independent exhibitors are required to check in with the Livestock Superintendent at the Livestock Office daily (starting the day after the animal is moved onto the fairgrounds) at three separate times: 8:00 a.m., 12:00 p.m. and 6:00 p.m. Exhibitors and Superintendent will do three walkthroughs per day to inspect pens for cleanliness and confirm water and feed have been provided to each animal.
14. If the exhibitor fails to meet any of the above listed rules, they will NOT be eligible to show as an independent exhibitor for the following year.

## LOCAL RULES

---

1. See Department for area designations and pertinent rules. Unless otherwise specified, departments shall be limited to members of Colusa County 4-H and FFA programs or independents who are residents of Colusa County.
2. The exhibitor assumes all risk of injury or damage caused by, or to, their animal
3. Animal Ownership: Large market animals must be owned and under the exhibitor's care and possession no later than the following dates:
  - a. **Beef—February 9, 2026**
  - b. **Swine, Sheep, Goats—April 10, 2026**
  - c. **Breeding Animals, Rabbit, Turkey and Poultry Meat Pens—May 9, 2026.**
4. Replacement of Injured or Deceased Animals: If a market animal is seriously injured or dies prior to fair, a veterinary report or necropsy must be completed by a licensed veterinarian. The exhibitor must then contact the CEO, who along with the Livestock Superintendent, will determine whether an ownership variance will be granted. Animals that are granted a variance will not be eligible to compete in the Champion Drive.
5. Livestock may arrive on the grounds after 4:00 p.m. Monday of fair week. All breeding stock must be on the Fairgrounds prior to the official weigh-in time for the applicable species and are subject to and must pass a veterinary inspection. See the livestock schedule for species specific times. No vehicles will be allowed in the livestock area at any time after 6:30 p.m. Tuesday unless the vehicle has an on-grounds parking pass.
6. In accordance with State Rule X (Animal Health Rules) all large animal entries shall be health checked on Tuesday. Any animals that do not pass the health inspection will be required to leave the grounds immediately.
7. All market animals must be clean and dry prior to being weighed.
8. Weigh masters will be provided by fair management. No pre-weighing will be permitted. If any weight is contested, it must be done immediately. The animal will be taken off the scales, the scales balanced, and the animal re-weighed. No re-weighs will be permitted after the animal leaves the scale area.
9. All bedding shall be provided by the exhibitor, including first bedding. Qualified bedding can be wheat or barley straw, pine or cedar shavings mix, or wood chips.
10. Exhibitors must furnish feed and care for their exhibits for the duration of the fair.
11. All livestock pens and stalls must be cleaned by 9:00 a.m. each day of the fair and be kept clean throughout the day. On Sunday, of fair week, pens must be cleaned out after 9:00

a.m. due to the shipping of sale animals.

12. Exhibitors must show their own animals. If an exhibitor has two animals in the same class, another exhibitor may show the second animal if they are a valid member of the organization that the original exhibitor belongs to, i.e. 4-H for 4-H, FFA for FFA, and independent exhibitors would acquire another independent exhibitor. Only the CEO may release the exhibitor from this rule.
13. Exhibitors may show a maximum of two large market animals at the fair. Exhibitors may only weigh-in 2 market animals at the official weigh-in. If an exhibitor is concerned that one of their animals will not make weight, the exhibitor must contact the livestock office prior to Monday of fair week, to arrange weighing a third (back up) animal. Ownership pictures of the backup animal must have been submitted at the entry deadline.
14. Exhibitors (4-H, FFA, and Independent) who are exhibiting market and/or breeding animals at the fair are expected to groom and care for their animals while at Fair. Exhibitors may help each other in the fitting and grooming process. Parents, 4-H leaders, and agricultural advisors (teachers) of these junior exhibitors can offer assistance or educational instruction if the exhibitor is actively engaged. Exhibitors, parents, leaders, and advisors found to be in violation of rule 14 will be issued a written warning. If the violation continues, the exhibitor will not be allowed to show or sell their animal in the auction.
15. To be eligible to sell a market animal at the junior livestock auction, all market animal exhibitors must show and sell in their show uniform and their market animal must be judged market ready.
16. A Declaration of Medication Form is required for all market animals at time of weigh-in.
17. Market animals not meeting the minimum weight requirement have until 7:00 pm on Tuesday to leave the grounds. If this animal is properly entered in showmanship and is the only animal the exhibitor has brought to the fair it may stay to be used for showmanship.
18. Only one item can be sold at auction.
19. Animals entered in the market division may not be entered in the breeding division, or vice versa. Any violations of this rule will exclude the offending exhibitor from competition in all departments of the fair.
20. No exhibitor may exhibit an animal in a market class once it has been sold as a market animal through a junior livestock auction. These animals may be shown following the 30-consecutive day ownership requirement as breeding animals. All Champion and Reserve Champion market animals will be permanently identified by the Colusa County Fair if sold through the Jr. Livestock Auction.
21. All market and breeding animals must stay in the designated livestock area. Animals are not allowed in the RV, carnival, or exhibit building area.
22. Violation of any of the above rules may result in disqualification of the exhibitor, market / breeding animal(s) from all classes and the junior livestock auction as well as the possible forfeiture of all premiums.
23. Colusa County Fair has adopted State Rule V. Protest, 1 thru 15 as their Protest Policy; see the State Rules on the Colusa County Fair website.
24. Use of blocking stands, blowers, etc. will be allowed only in areas designated by fair

management.

25. Exhibitors will need to bring a generator to run blowers and portable cooling systems. These items may not be plugged into the barn's electrical outlets.
26. Fair management will designate areas around the sheep/goat barn for pop-up tents. Each community will be given a space to use for fitting and tack. No additional tents will be allowed around the sheep/goat barn area. Sides are not allowed on the tents. Pop-up tents will be allowed only on the south side of the swine barn. It is a first come, first served basis. Tents may not be set up until after weigh-in on Tuesday.
27. There must be a minimum of five exhibitors that show in a class, for that species to be eligible for the Master Showmanship competition.
28. Release of second market animals, breeding stock and tack will be Wednesday & Thursday 5-7pm and Friday 6-8am or as scheduled by the Livestock Superintendent. NO LIVESTOCK OR TACK shall be released from the grounds AT ANY TIME without a signed release from the Livestock Superintendent/Fair Manager AND by Gate Security following trailer inspection.
29. Fair management will cancel and return all entries that are received after available facilities are filled. Livestock will not be allowed to show out of a trailer.

## CREENTIALS

---

If a wristband or pass is lost, a replacement must be purchased at the gate.

## LIVESTOCK RV AREA

---

1. If a trailer space is needed, exhibitors must contact the Entry Office to request a trailer space application. Additional rules and regulations apply.
2. A fee per trailer will be charged during Fair time.
3. **NO dogs or other pets allowed on the fairgrounds.**
4. The State Health Department has ruled that no trailers will be allowed on the grounds with open drains.
5. House trailers will be allowed only as sleeping facilities.

## **INSURANCE**

---

County, District, and State Fairs cannot legally carry liability insurance covering exhibitors and/or their exhibits. Liability insurance is the responsibility of the exhibitor. Therefore, Junior Exhibitors are encouraged to consider obtaining a liability insurance policy covering themselves and their exhibits.

1. Limited to Colusa County Residents.
2. Show uniforms, as noted under the Junior Livestock Department Local Rules, must be worn in the sale ring.
3. Market animals must be shown as individuals in their respective classes and be judged market ready to be eligible to sell in the junior livestock auction.
4. All rabbit pens, poultry meat pens, and turkeys receiving a blue ribbon are eligible to participate in the JLA. The exhibitor is responsible for delivering the carcasses to the buyers following the sale.
5. The sale will be limited to one animal per exhibitor, except rabbits and poultry, which will be limited to one meat pen per exhibitor (rabbits: 3 animals per pen; poultry: 2 animals per pen).
6. Any exhibitors not wishing to sell their market animal must tell the show ring announcer or livestock office by the conclusion of their species show.
7. Unless otherwise specified by the exhibitor, by the completion of showing, the highest placing market animal shown by the exhibitor will sell at the auction.
8. All Champions animals must sell. In the event an exhibitor has more than one Champion animal, the highest placing Champion must sell. Champion animal exhibitors will need to take a new picture with their buyer during the sale on Saturday.
9. Exhibitors must sell their own animal in the JLA. Only the livestock show committee chairperson and the exhibitor's leader or advisor, acting jointly, may release the exhibitor from this rule.
10. After the animal is sold the exhibitor shall return his/her animal to its pen and continue to feed and water the animal until it is shipped on Sunday.
11. Animals not sold through the Junior Livestock Auction remain the responsibility of the exhibitor and must be removed from the Fairgrounds prior to the start of the Junior Livestock Auction on Saturday, unless otherwise authorized by the Livestock Superintendent. Load out time for extra animals only Wednesday & Thursday 5-7pm and Friday 6-8am.
12. Live pick-up of purchased animals will occur immediately following the completion of the auction, or as approved by the Livestock Superintendent. All animals must be paid in full and

have a signed release from the Livestock Superintendent before leaving the Fairgrounds. Load-out authorization paperwork is required at Gate Security. The Colusa County Fair will ship only those animals sold through the auction.

13. Exhibitors' checks will be released to each project's 4-H leader, FFA advisor, or processed through Colusa-Glenn Farm Credit, as applicable.
14. All exhibitors selling animals at the auction shall be assessed a seller's commission fee and other species-specific deductions to offset auction expenses. No profits will be realized by Colusa-Glenn Farm Credit, the financing and operating agency of the sale, auctioneers, or the fair management. Any reserves of the assessed sellers fee will be retained by the Fair Foundation for contingencies, future sales, and barn area improvements.
